## PLAYGROUND MAINTENANCE & REPLACEMENT:

As a result of the playground's popularity, the play bar requires regular raking and even distribution in some areas of high use.

## **VILLAGE RECREATION GROUND:**

Our Groundsman, took advantage of the dry spell to top the field grass during the first week of February. The following day the rain began to fall and the recreation ground, like all surrounding fields, is once again saturated.

We are seeking advice and quotes for service repair and/or replacement the two entrance barrier gates that require attention. The entrance on Martins Hill Lane is a mishmash of wooden fences either side of a pedestrian swing gate and a narrow vehicular access gate. This arrangement is not DDA compliant, is not wide enough for a fire engine and presents a risk of unwanted incursions. We have a quote of £3620 Net to remove all existing elements including fencing and replace with a Woodstock kissing gate with mesh infill and a wider 4m galvanised barrier gate, also with mesh infill, and make good with uniform fencing either side. Additional quotes being sought.

## **FLY TIPPING / CCTV**

BWPC has considered use of CCTV to identify individuals and vehicles fly tipping in the past but was advised by BCP against trying to introduce due to the legal implications at the time.

Unfortunately, rural parish councils suffer widespread fly tipping due to the number of quiet country lanes where a truck load of builders waste or a car boot full of rubbish can be dumped without being observed or interrupted by passers by.

Deployable cameras that capture images of the culprits and vehicle registration numbers set up at known fly tipping sites can be very effective. Signage is required to ensure the general public are



aware of the cameras and this means the committed fly tipper will move to a nearby site where there is no surveillance. Burton and Winkton Parish Council has numerous locations where loads can be dumped without being spotted which means that CCTV is unlikely to be a deterrent.

# **SCOUT HUT**

Despite repeated requests the Fire Risk Assessment (FRA) due at the end of 2022 remains outstanding - **CLERK TO CHASE** 

Following the previous parish council meetings, the issue of rubbish and discarded items to the side of the scout hut has been discussed with the tenant executive group, with assurances given these items would be removed, however, as of today's date the items remain. Given the fire risk and risk of damage to both tenants' huts and neighbouring private properties, it is now appropriate to officially write to the tenant requesting the immediate removal of all items at the side of the hut.

**Staple Cross & Preston Lane fingerposts** – awaiting repair to prevent the fingers being swung to give the wrong directional information. At a previous meeting the BWPC agreed costs of remedial works to retrofit a countersunk tamper resistant torx driven screw. **Proposed Winkton fingerpost** – previously agreed replacement of mishmash of signage currently located on the verge at Winkton Green. Awaiting update from BCP re clearing existing signage and any necessary permissions BWPC will require to reinstate heritage fingerpost CLERK TO CHASE AND UPDATE

# STAPLE CROSS: - NO FURTHER UPDATE

Short wooden posts/bollards have added to the area around the monument, presumably to stop parking on the grassed area. It is not known if this work was undertaken by BCP Highways or Roeshot development contractors

Taylor Wimpey provided the following response to question raised by Alinda Howland relating to the proposed development of Roeshot Hill and the impact on Staple Cross a historic landmark and scheduled monument.

QUOTE: Re the Scheduled Ancient Monument, again the plans have not yet been finalised. A Heritage Management Plan has to be prepared by Taylor Wimpey and approved by the Council prior to the commencement of any works in this parcel of land. The Outline Planning Consent stipulates that the developer has to undertake an archaeological investigation of the Scheduled Ancient Monument, repair the cross (resetting and repointing the stone by specialist stonemasons) and fund landscape works, but again no detail has yet been prepared.
